RE: Motion to Modify or Terminate Probation

Please find attached a sample format to be used in a Motion to Modify or Terminate Probation or Community Control. This matter is *related* to your criminal case, but we cannot represent you unless the Judge appoints us to do so.

You will need to complete the pleadings with all of the appropriate information in the spaces provided, including: your <u>name</u>, <u>case number</u>, and the <u>trial division</u> in which your case was heard. Where indicated, circle the parts that apply to you and fill in the blank spaces.

The Order should be completed with your name, case number, and division, but the signature line for the judge must remain blank. The judge will sign the Order in court.

In most divisions, you must contact the judicial assistant of the judge whose division handled your case and request a date for the motion to be heard. Once the judicial assistant provides a date for the hearing, complete the Notice of Hearing.

You must file the Motion, Order, and Notice of Hearing with the Clerk of the Circuit Court.

You must then send a *copy* of the Motion <u>and</u> the Notice of Hearing to the Office of the State Attorney and your probation or community control officer.

It is important that you bring with you to court all verification of any special conditions of probation/community control that you have completed. Be sure to keep copies of all of the documents.

INSTRUCTIONS

Please follow these instructions in order to properly prepare your motion for modification or termination of probation. Although this matter is *related* to your criminal case, this office cannot represent you unless the judge appoints us to do so.

You will need to complete all of the attached forms as follows:

- 1. Please fill in your <u>name</u>, <u>case number</u>, and <u>division</u> on <u>all</u> of the attached documents (the Notice of Hearing, Motion, and Order).
- 2. Fill in the blanks in the Motion, Order and Notice of Hearing.

 Words in **bold** and separated by a slash (/) signal a choice. You must circle one of the options. For example, if your case was a felony case, it was heard in Circuit Court. Circle the word "CIRCUIT" in the heading of the MOTION, NOTICE OF HEARING AND ORDER.
- 3. Contact the judge's judicial assistant in order to get a hearing date on your motion.
- 4. Once you have a hearing date, fill it in on the Notice of Hearing.
- 5. You must sign the Notice and Motion (**do not sign the Order**).
- 6. Once the documents are completed, you must:
 - A) File the **ORIGINAL** motion, order and notice with the Clerk's office.
 - B) Send a <u>COPY</u> of the motion and notice to the State Attorney's Office, 3rd floor 800 E. Kennedy.
 - C) Send a <u>COPY</u> of the motion and notice to your probation/community control officer.
 - D) If the case is before Judge Ficarrotta make a copy and give it to the information desk on the 1st floor of the Courthouse Annex
- 7. When you come to court, bring the documents that verify the conditions you claim have been completed.
- 8. Be sure to keep copies of all documents for your records.
